

#### 1 INTRODUCTION

Environmental protection is a duty for the Eurobank Group. In 2003, the Bank initiated its environmental protection effort by enacting its official Environmental Policy, which aims at mitigating its environmental impacts.

The Environmental Policy is implemented through the introduction and operation of an Environmental Management System (EMS). In 2004, Eurobank became the first bank in Greece, and remains one of the few banks in Europe, to have established an externally certified, ISO 14001 compliant Environmental Management System (EMS). An annual surveillance is performed on the EMS by TUV HELLAS, an independent and accredited Certification Agency.

In 2009, the System moved closer to "maturity" through the completion of procedures for the official listing of Eurobank in the EMAS Register of the Ministry of Productive Reconstruction, Environment and Energy (formerly the Ministry for the Environment, Energy and Climate Change - MEECC) (registration number EL-000080) of European Organizations that adhere to the EMAS regulation (Regulation EC/761/2001) on Environmental Management. As stated in the European Commission's official documents, this transition facilitates the improvement of environmental performance, and increases the transparency and reliability of environmental management.

Environmental issues are deemed crucial to Eurobank's Management, and have been entrusted to the Group Environmental/Sustainability Committee, which is chaired by the Bank's Deputy Chief Executive Officer, Group Chief Operating Officer (COO) & International Activities. The Committee comprises the heads of all the Bank's Units that are involved in the implementation of the environmental policy, so that pertinent decision-making and planning are dealt with at the strategic level.

The Group's environmental activities and the promotion of Sustainable Development are coordinated by its Group Environment & Quality Division, which was established in 2004 with the main purpose of seeing to the implementation of the Environmental Policy and the achievement of the targets emanating from it.

The improvement of the Bank's environmental performance does not only foster its sustainable growth, but also generates competitive advantages, such as:

- the reduction of operating expenses
- the exploitation of new business opportunities, such as the development and promotion of "green" banking products.

One of the main principles of the Eurobank group is that international commitment to Sustainable Development can only be achieved through partnerships. To this end, the Group has joined the United Nations Environment Programme Finance Initiative (UNEP FI) since 2005, and works together with the United Nations Environment Programme on the Protection of the Environment and the promotion of Sustainable Development. Represented by its Group Environment & Quality Division, the Bank has held senior administrative positions at the Global Steering Committee, the Banking Commission, as well as the Chairmanship of the European Task Force of UNEP FI (2010-2014). Through its influential role in the proceedings of this Organization, the Group has actively contributed to the drafting and publication of the first of its kind Sustainable Banking Guide, which is a best practice manual for banks worldwide; the Guide is available at: www. unepfi.org/fileadmin/documents/guide\_banking\_statements.pdf.

Moreover, the Bank is a member of the expert panel of the European Commission Energy Efficiency Financial Institutions Group (EEFIG) and the Sustainable Development Committee of the Hellenic Bank





Association, and is a sustainability ambassador in the "Sustainable Greece 2020" initiative, which aims at raising awareness on Sustainable Development and Responsible Entrepreneurship.

The Management of the Eurobank group views to gradually extending the implementation of the Environmental Policy, as well as disseminating its certified and award-winning environmental practices, to the Group's subsidiaries in Greece and abroad. Moreover, Environment Offices have been operating in the Group's subsidiary banks in Serbia, Bulgaria, and Romania, with the sustained support of the Group Environment & Quality Division, with the target of continuously improving the environmental profile of these companies.

The scope of the Bank's Environmental Management System is the "Provision of Banking and Financial Services", the application position is Greece while the Certification extends to all Bank's Central Divisions and branches which resulted following the operational merger with New TT Hellenic Post Bank that was completed in 2014 (31 buildings and 506 branches of the Eurobank and New TT Branch Network as they are presented in Appendix I)

This report has been drawn up, validated, and verified following the annual audit by the accordingly accredited Certification Body, as part of the fulfilment of the EMAS requirements, and in order to provide the public and all interested parties with credited environmental information about Eurobank.

The information included in this report refers to the environmental policy, environmental impacts, performance and results of Eurobank, concerning the total of the Bank's points of presence, based on the environmental objectives and targets it has set.




#### 2. ABOUT EUROBANK

#### 4. ENVIRONMENTAL MANAGEMENT SYSTEM


The Environmental Management System (EMS) of Eurobank is an integrated system for the comprehensive and sound management of all environmental issues that arise, or may arise, from the Bank's operation. For a description of the Environmental Management System (EMS) you may refer to the Environmental Report of 2011 (posted at the websites of the Bank and the Ministry PREE)<sup>1</sup>.

The EMS implemented by Eurobank is based on the EMAS guidelines, and aims at ensuring compliance with the Environmental Policy within the scope of the Bank's operations. Moreover, it is based on a specific Structure and Organization, as well as on established procedures for monitoring, measuring and recording environmental performance in the immediate, and wider, environment within which the Bank operates.

In this respect, the Management of Eurobank has appointed the Deputy CEO, Group Chief Operating Officer (COO) & International Activities as its representative on environmental issues, in order to ensure the coordinated and responsible promotion and implementation of the Environmental Policy and the EMS in all locations and units of the Bank. The Group Environmental/Sustainability Committee reviews the Environmental Management System, while responsibility for the implementation of the Environmental Management System lies with the Group Environment & Quality Division.

The Head of the Group Environment & Quality Division has been assigned specific duties and while responsibilities, the channels of communication environ-mental regarding management with the Management, as well as with other Departments Divisions, are illustrated in the following Organization Chart of the Bank.

The Management believes that the successful implementation of the EMS calls for the realization of the basic principles related to the protection of, and respect towards, the environment, which eventually leads to the personal, actual involvement of each employee.

# **5. ENVIRONMENTAL ASPECTS AND IMPACTS**

The environmental aspects of the Bank are described in detail in the Environmental Report 2013, which is available at www.eurobank.gr. In 2014, all environmental aspects remained the same with the previous years with the only exception of the administrative part of the "Electricity consumption by lighting, electronic equipment, air conditioning, ventilation and chemical energy" aspect, which in 2014 was upgraded to an Energy Management System in accordance to ISO 50001:2011.

# 6. ENVIRONMENTAL OBJECTIVES, TARGETS AND PROGRAMMES

Environmental objectives and targets that correspond to the environmental aspects and aim at continually improving the Bank's environmental performance are set each year. In order to achieve these wider objectives, as well as the specific quantitative targets, the Bank designs and implements environmental programmes. The year 2014, when performance indicators resulted from the consolidated data concerning the merged banks, is set as the baseline year for setting the targets for the forthcoming years. The Bank's objectives, targets and implementation programmes for 2015 are modified as follows:

#### 7. ENVIRONMENTAL PERFORMANCE

The direct and indirect environmental impacts from the Bank's operation are reflected on the published data concerning environmental performance. This way, Eurobank ensures both transparent operation, as well as the enhancement of the effort to continually improve its "ecological footprint", as part of a detailed mechanism of material and resources flow analysis and management within the Organization, which includes "green" procurement, the use of materials and the disposal of waste. In order to ensure that the Bank's environmental performance is comparable to that of the rest of the financial sector, special indicators have been developed on the basis of internationally accepted standards and Directives.

A key factor, which had a drastic effect on 2014 performance indicators, was the operational merger between Eurobank and New TT Hellenic Post Bank (New TT HPB). The merger led to a substantial increase in the number of the Bank's points of presence, as well as the number of employees, with corresponding increases in natural resource consumption, gas emissions, and waste. Performance indicators have been based on consolidated data; as a result there may be significant differences as compared to 2013 performance, in regard to many indicators.

# 7.1 Environmental Performance Indicator

The EMS keeps analytical data on the environmental performance of Eurobank. In brief, the environmental performance for 2014 (January 2014-December 2014) is the following:

# 7.2 Environmental Management

The Bank's EMS includes programmes and initiatives divided into six sectors:

- Personnel Training/Information and Awareness
- Natural resource (such as paper and electricity) savings
- Recycling and waste management
- Reduction of Greenhouse gas emissions
- Environmental risk assessment of client financing
- Development and promotion of "green" banking products

# 7.2.1 Personnel training, updating and awareness

Eurobank actively promotes awareness-raising among employees, encouraging them to be active on environmental issues through, for instance the identification of personnel training needs on Environmental Management. The Bank acknowledges that raising personnel awareness is crucial for the successful implementation of the Environmental Management System.

In order to train its employees on its Environmental Management System, the Bank has been implementing an e-learning programme, which in 2014 was attended by 142 people from the New TT Branch Network (NTT BN), with the aim of ensuring the fastest possible diffusion of the Bank's environmental culture to the new personnel, changing the ratio of environmentally trained employees to 37.86% of the workforce. Among other things, e-learning contributes to reducing trainee commutes, further reducing greenhouse gas emissions.

Moreover, the Bank's Intranet includes a page especially dedicated to the continuous updating of personnel on environmental management issues, while certain individual issues pertaining to the Bank's environmental programmes are regularly communicated to the employees, improving both information and involvement.

#### 7.2.2 Natural resource savings

#### 7.2.2.1 Energy and climate change

Despite the fact that the Bank's contribution to the greenhouse effect mainly concerns indirect gas emissions (through electricity consumption), the significance of Climate Change makes monitoring energy






consumption of all types, and the corresponding emissions, one of our top priorities. In this context, in 2014 the Energy-Saving Programme was upgraded to an Energy Management System in accordance to ISO 50001:2011.

Since 2008, the Bank has been using the internationally accepted GreenHouse Gas Protocol, GHG (http://www.ghgprotocol.org/) for monitoring its Energy-Saving Programme.

This protocol was established by the World Business Council for Sustainable Development and the World Resources Institute, with the aim of systemizing energy management by enterprises and organizations. Thus, the data collection and analysis systems provide advanced monitoring and decision-making capabilities.

The Protocol provides a framework for recording and allocating energy consumption, as well as calculating direct and indirect Greenhouse gas emissions.

Direct consumption refers to the combustion of oil and natural gas for heating purposes. Indirect consumption refers to the use of electricity for the Organization's operations. The corresponding Greenhouse gas emissions are divided to direct (Scope 1) emissions from oil and natural gas combustion. and to indirect emissions from the electricity bought by the Bank (Scope 2), as well as emissions corresponding to the business trips of employees (Scope 3).



In 2014, and in regard to the entire Bank, including data from NTTBN points of presence, the total consumption of heating oil amounted to 48,127 litres, natural gas consumption amounted to 2,510,195 kWh, electricity consumption amounted to 68,280,149 kWh, while business air travel reached a total of 1,600,020 miles. In 2014, total energy consumption increased by 20.28% year-on-year (56,768,811 kWh). However, as far as Eurobank points of presence are concerned, prior to the operational merger with NHPB, consumption for the entire 2014 stood at 55,677,154 kWh, down by 1.92% year-on-year. It should also be noted that the target that had been set (See Environmental Report 2013, page 16, 1st target) in regard to the consolidated measurement of consumption data at both Eurobank and NTTBN points of presence.

Electricity consumption per employee amounted to 7,856 kWh/employee as compared to 8,074 kWh/employee in 2013, reduced by 2.71%.

Energy management and the monitoring of the relevant indices aim at taking the appropriate decisions concerning interventions that will minimize the Bank's share in the Greenhouse effect and Climate Change. As part of the effort to reduce direct greenhouse gas emissions from the combustion of oil for heating purposes, we developed infrastructures for gradually introducing the use of natural gas in Administration buildings, anticipating, at the same time, an improvement in the performance of the relevant heating systems by 5-10%.





Moreover, in 2014, based on the findings of the energy consumption monitoring project, interventions were made to both the existing equipment and to the design of the new premises' concerning internal lighting, illuminated signs, air conditioning and electrical installations.


The selection of energy-efficient (e.g. Energy Star labelled) equipment was continued in 2014 for the replacement of the old electrical equipment of the Nea Ionia building complex.

In addition, the use of video conferencing for covering remote communication requirements continued to increase in 2014, along with the use of e-learning courses, in order to reduce business travel and the resulting  $CO_2$  emissions.

Total  $CO_2$  emissions increased by 18.64% in 2014 as a result of the merger, and amounted to 50,040.39 tons of  $CO_2$  (641.83 direct, 49,398.56 indirect), as compared to 42,179.31 tons in 2013.

Similarly, total greenhouse gas emissions (GHG) in carbon dioxide equivalents ( $CO_2e$ ) amounted to 50,040.46 tons. Total greenhouse gas emissions (GHG) in carbon dioxide equivalents ( $CO_2e$ ) per area unit stood at 0.14 tons/ $m^2$ , and 5.76tons per employee , reduced by 4.03% and 5.68% respectively as compared to 2013.

In detail, the contribution of greenhouse gases (carbon dioxide, methane, nitrous oxide) in total emissions, as well as the annual gaseous pollutant emissions deriving from the use of oil and natural gas for 2014, were the following:

The major interventions made in 2014, in both the existing equipment, and the design of new premises, concerning internal lighting, illuminated signs, air conditioning, electrical installations and natural gas facilities, were the following:

#### a. Lighting

In 2014, new lighting appliances, featuring energy-saving technology (T5 fluorescent lamps, 4x14W and electronic ballasts) were installed in all the branches and premises that underwent extensive repair-renovation works. The reduction of lighting energy consumption is estimated at 25%, at least as compared to the type of lighting appliances that was used till now. Moreover, the Bank installed, and conducted a technical-economic evaluation of, LED Tube 2x18W light units, which would replace the corresponding T8 2x36W Fluorescent Lamp and Magnetic Ballast used for the 24-hour illumination of the underground garage of the Nea Ionia building complex and the underground garage of the Petmeza building. Energy-savings are roughly estimated to at least 60% versus the previous situation (LED vs Fluorescent magnetic ballast).





#### b. Illuminated signs

86% of the illuminated signs posted on the Bank's branches and buildings are fitted with auto night-off facilities. In mid-2014, the Bank started replacing NEON and fluorescent units of the branch network's illuminated signs with LED light units. More specifically, by the end of 2014, 30% of the branches had been refitted with the new LED light units (155 branches out of a total of 506). In addition, at the end of 2014 the Bank started replacing the lighting units of its illuminated BRANDWALLS with LED light units. It is estimated that this will generate energy savings of at least 80%.

# c. Air conditioning

The branch network and office buildings of the Bank have been fitted with energy-saving air conditioning systems, which can also improve conditions in the corresponding premises, thus improving their ventilation, apart from covering cooling-heating needs.

More specifically, the new air conditioning systems installed in 2014 concerned:

- a) variable Refrigerant Flow (VRF) Systems, which were combined with air to air exchangers that enable the pre- conditioning of external ("fresh") air with low energy consumption.
- b) split-type autonomous air-conditioning units, with inverter controls, of high energy class (A or B+), using environment-friendly Freon R410a and showing high coefficients of performance.
- c) water systems for air-cooled, Energy Class A, air-conditioning structures, with high coefficients of performance, which use the environment-friendly R410A refrigerant.

The installations were made at the branches of Kavala (226), Lagada (376), Koukaki (072), Egio (152), Livadia (762), Messini (317), and Karditsa (711), the Pesmazoglou building, as well as the Bank's offices in the Thessalonikis & Florinis Str. building.

# d. Improving the performance of electrical installations

In 2014 certain actions and interventions were initiated with the aim of reducing energy consumption by electrical installations in office areas and branches. These actions include:

- Extension of the BMS system to the floors of the Pesmazoglou building, which was refitted as well.
- Installation of motion detectors for the operation of lighting installations in underground parking spaces (Petmeza building garage).
- Design of electrical lighting circuits in a way that enables keeping lights switched off in zones of office spaces and branches located near windows.

#### e. Other energy-saving measures

Along with the above measures, the Bank continued to inform, and raise the awareness of, its employees on energy-saving issues, as follows:

- Provision of information by the EQD, through the Environmental Management Guide, which
  includes the "Ten Energy-Saving Tips" that comprise simple environmental practices and guidelines
  about how each employee can contribute to this effort.
- Distribution to all branches, by the EQD, of a special Environmental Questionnaire, which enables employees to comment among other, on energy issues as well.

# Distinction for the Eurobank group at the Environmental Awards 2015

Once again, the Eurobank group was distinguished for its environmental performance at the Environmental Awards 2015, by winning the GOLD award in the "Energy Efficiency in Business" category. Eurobank is well





acquainted with this contest, which promotes Environmental Protection and Sustainability best practices, procedures, or initiatives of businesses, organisations, and agencies operating in Greece, having won two Environmental Awards in 2013, in the "Sustainable Procurement" and "Climate Protection-GHG Footprinting" categories.

This new Energy Efficiency award confirms, on one hand, the high level of the Bank's knowhow and its focus on organisational and technical issues pertaining to this subject and, on the other hand, the environmental awareness of its employees, who contribute to rational energy use with small everyday actions.



#### Planning for 2015

The responsible Services of the Bank are planning the following activities during 2015:

- a) The following actions will continue to be realized in all the Bank's new Branches and office spaces, as well as all areas were extensive refurbishment works are implemented:
  - the installation of environment-friendly roof-lighting appliances, with T5 light units and electronic hallasts
  - the replacement of illuminated signs with LED lights
  - the installation of LED lights in underground parking areas
  - the installation of VRF air conditioning systems, and autonomous air-conditioning devices, as well as the installation of air-cooled water air-conditioning systems, of energy class A
  - the installation of a heat recovery ventilation system

#### b) Energy saving campaign

In January 2015 the Group launched an energy-saving campaign titled "Good Energy — Don't waste it, use it for something good", which aims at significantly raising employees awareness, by combining the environmental with the social gains and incentives, since part of the energy saving will be donated to heat the Lyreion Children's Foundation. The awareness campaign includes the following actions:

Communication of the campaign through a special banner on the Group's intranet site, e-mails to all employees, and periodic reminders of the Ten Energy-Saving Tips via e-mail.

Placement of special energy-saving stickers in all administration buildings and branches, next to light and air conditioning switches and Managed Print Service devices, as a permanent incitement of proper energy use.



Distribution of a quarterly Newsletter containing data on the energy-saving campaign, as well as other environmental subjects

- c) Preparation of technical inspection reports concerning branches selected from the Bank's annual power consumption data list, in collaboration with Eurobank Properties Services (EPS). The inspections will be performed as part of the collaboration with EPS during 2015 and will include, among others, an analytical recording of the consumption profiles at the premises, the installation of meters at each point of measurement, the identification of the equipment or functions in need of immediate improvement etc.
- d) Scheduling of energy-saving actions in branches/buildings as part of the Shared Benefit Energy Performance Contract with EPS, for the second half of 2015.
- e) Investigation of the potential for, and the implementation of, interventions in the E/M infrastructures of the N. Ionia complex, ensuring efficient energy management in regard to the special agreement with the Public Power Corporation S.A.






f) In addition, following the "absorption" of New TT HPB & New Proton Bank systems by the Data Centre of Nea Ionia, the following issues, which had been temporarily suspended due to the merger in 2014, shall be reassesed:

- Installation of a system for Data Centre's Energy monitoring and management.
- Design, analysis and evaluation of a system that uses low external air temperatures to assist in the operation of air-conditioning installations during the winter (free cooling) with the aim of ensuring the more effective/efficient use of air-conditioning in the Data Centre.
- g) Pilot installation of LED light units in office spaces.
- h) Replacement of old, energy-intensive air-conditioning systems in 4 branches.

#### 7.2.2.2 Paper

The rationalization and control of paper consumption is one of the Bank's major environmental targets. However, annual paper supplies increased by 42.77% year-on-year in 2014 and stood at 574,138 kg, owing to growth of the branch network after the merger. As a result, the 465 kg target that had been set for 2014 (See Environmental Report 2013, page 16, 2<sup>nd</sup> target), was not achieved.


Annual paper supplies per employee increased by 15.49% as a result of the merger, to 66.05 kg, as compared to 57.20 kg per employee in 2013.



The paper consumption-reducing actions realised by the Bank, which are described in detail in the Environmental Report 2013, were continued during 2014 and were also extended to the NTT BN.

#### 7.2.2.3 Water

Water is the most important natural resource of our times, and for this reason the Bank attaches great importance to its preservation. Watersaving measures include the installation of aircooled air conditioning systems, which consume less water. In 2014, water consumption amounted 86,204 to cubic corresponding to a year-on-year increase of 26.77%, as a result of the operational merger between the banks. The water consumption per employee indicator rose by 2.55%, to 9.92 m<sup>3</sup>/employee, compared as m<sup>3</sup>/employee in 2013. The Bank has set the target of rationally reducing water consumption, stabilizing it at 9 m<sup>3</sup>/employee per year.







#### 7.2.3 Recycling and waste management

The Bank makes every possible effort to recycle and/or redirect all types of waste. All solid waste, depending on their type, is collected in the appropriate bins or at especially designated areas, to be delivered either to the suppliers of the original materials, or to licensed waste management contractors.

Our effort begins with the prudent supply of materials whose waste has limited environmental impacts, such as dry batteries or asbestos-free refurbishing materials.

Today, the Bank is following up on waste streams, in order to ensure their best possible management and the reduction of environmental impacts. In 2014, the recycling and waste management programmes were extended to the branches of the NTTBN.

Therefore, the Bank has been monitoring and managing the lifecycle of the following materials within the organization:

- 1. Toner cartridges
- 2. Paper and Packaging Materials
- 3. Waste Electrical & Electronic Equipment
- 4. Light units
- 5. Batteries
- 6. Credit Cards

The permanent objective of the Bank is to continue expanding its recycling programmes in order to ensure the safe management of all recyclable outgoing materials.

#### 7.2.3.1 Toner cartridges

In 2014, the toner cartridge management programme that is implemented in the Bank's units and branches was extended to the New TT Branch Network. This programme upgrades the role of recycling, since the aim is to reuse all toner cartridges. Any cartridges that cannot be refilled are delivered to properly licensed agencies for recycling.

In 2014, total toner supply amounted to 3,713 units, as compared to 3,776 in 2013. This 1.67% reduction, which was achieved despite the operational mergers with the two banks, is due to the further expansion of the "Managed Print Services" programme during 2014. Total toner cartridge supply per employee amounted to 0.43 units/employee in 2014, while recycling/refilling concerns 100% of blank toner cartridges, through the relevant management mechanism, thus leading to the achievement of the relevant target that had been set for 2014 (see Environmental Report 2013, page 16, 4<sup>th</sup> target).

The aim is to sustain the programme's smooth implementation all over the country during 2015, when the "Managed Print Services" programme is scheduled for implementation in the entire branch network, thus leading to the further reduction of toner supplies and the 100% safe management of blank cartridges.

#### 7.2.3.2 Paper and packaging materials recycling

In the first half of 2014, the paper recycling programme was revised in order to include the branches of the NTTB Network, as well as the branches of the Greek islands. A key change in the programme was the





inclusion of the use of municipal recycling systems, along with using the services of a recycling company for the management of paper and packaging materials. Thus, the Bank's points of presence where paper and packaging materials are recycled, increased by 62%, thus covering all Eurobank and New TTBranch Network buildings and branches.

The total quantity of paper recycled by the recycling contractor in 2014 amounted to 173 tons, and accounted to 30.20% of paper supplies, a ratio that seemingly falls below the 40-60% target that had been set for 2014 (See Environmental Report 2013, page 16, 3rd target). However, the actual quantity is much larger, since there are no measurements of the quantities channelled to municipal recycling systems, which account for more than 70% of the branches.

Finally, 0.38 tons of packaging materials (plastic, aluminium, paper) were recycled.

# 7.2.3.3 Electrical & Electronic Equipment

In 2014, the Bank continued its programme for the safe disposal of waste (electrical & electronic) equipment either through reuse (within the Bank's units) and donations to third bodies, or through the recycling of any devices that cannot be reused. Recycling is carried out in cooperation with the official system established by the Ministry of Productive Reconstruction, Environment and Energy (formerly the MEECC), and its pertinent licensed associates. Almost 120,020 kg (8,180 units) of equipment were recycled in 2014, accounting for 100% of waste equipment and leading to the achievement of the target that had been set (see Environmental Report 2013, page 16, 6<sup>th</sup> target). The target for 2015 remains the same.

The Bank continued its successful electronic equipment donation programme, as part of an effort to manage the lifecycle of the materials it purchases. Thus, in 2014 it donated 976 electronic equipment items.

#### 7.2.3.4 Lamps/Batteries

Used light units and batteries are types of waste that are regulated by the applicable environmental legislation. Their safe disposal prevents the pollution of both the soil and aquifer with heavy metals and other hazardous substances. In 2014, the Bank continued its cooperation with the agencies qualified for managing such materials. Overall, 12,472 units and 425 kg of burned-out light units were delivered for safe disposal.

In addition, batteries weighing a total of 4,219 kg were delivered for safe management, including large-scale UPS batteries withdrawn from administration buildings. Moreover, portable batteries were collected in designated areas in Attica (AFIS), leading to the recycling of a total of 562 kg.

The target of recycling 100% of waste light units and batteries was achieved in 2014 (See Environmental Report 2013, page 16, 5<sup>th</sup> target).

The target for 2015 is still to achieve the safe management of 100% of these materials.

#### 7.2.3.5 Credit Cards

The credit cards that have expired or have been cancelled and are returned by our customers constitute non-hazardous materials that we are managing. In 2012, the Bank started working with a company that undertook to manage these materials and export them to licensed recycling units abroad. In 2014, almost 180 kg of used cards were delivered for destruction and recycling. The target for 2015 is to manage 100% of





the expired or cancelled credit cards returned by our customers. Owing to the operational merger and the existence of different priorities for the Bank, there was no extension to the programme for collecting the expired credit cards that result from automatic renewals. However, certain methodologies for implementing this programme have been identified in order to choose the most sufficient one.

#### 7.2.3.6 Safe removal, management and permanent disposal of asbestos-containing items

As part of the operational merger between the Bank and New TT Hellenic Post Bank and the integration to the Bank of all the latter's buildings, certain asbestos-containing building and insulation materials were detected in the premises of the 2-6 Pesmazoglou Street building in Athens. Following a relevant authorisation by the Regional Authority of Attica, a total quantity of 7,290 kg of friable and non-friable asbestos-containing items were safely removed, managed, and permanently disposed of, by a licensed company.

#### 7.2.4 Environmental risk assessment

The Bank has developed a procedure for assessing the environmental risk of loans, especially those extended to highly polluting enterprises. Since 2004, Eurobank has adopted certain criteria for assessing the environmental risk of the businesses it cooperates with.

Presidential Decree 148 "on environmental liability with regard to the prevention and remedying of environmental damage - Alignment with Directive 2004/35/EC" was issued in 2009.

The purpose of this legislation is to establish environmental liability on the basis of the "polluter pays" principle, through the specification of measures, terms and procedures, so that the operator whose activity has caused the environmental damage or the imminent threat of such damage is to be held financially liable for taking the necessary measures for preventing and/or remedying environmental damage.

Given the increasing weight attached to environmental issues by societies, legislators and international agencies, as well as the implementation of the "polluter pays" principle on the European level, the Group works on expanding the scope of its environmental risk assessment and management system, in order to deal with such risks in a timely fashion, always in cooperation with its clients.

In this context, 4 environmental due diligence inspections were performed in 2014 prior to the approval and disbursement of loans. Similar inspections were also performed as part of monitoring the financed projects (15 environmental inspections).

In 2015, the Bank will continue these environmental inspections, actively contributing to environmental protection.

#### 7.2.5. "Green" Procurement Policy

Since the launching of its Environmental Management System, the Bank has stated, through its policy, that it wishes to transmit its environmental culture to its customers and suppliers. In this context, it has been gradually developing environmental criteria for evaluating both its suppliers, and the products and services they offer.





The existence of an environmental policy and an Environmental Management System has already been incorporated to the supplier evaluation criteria, while environmental labels (such as Energy Star, FSC, PEFC, Eco-Label etc.), are included in product specifications whenever practically possible. In addition, adherence to the environmental legislation is an explicit provision in all contractor agreements.

The Group's Procurement Policy includes special environmental regulations that promote sound environmental conduct among suppliers and ensure, whenever possible, the selection of environment-friendly products.

It should be noted that the Bank's "Green" Procurement Policy is seriously taking into account the peculiarities of the market, and aims at utilizing the Bank's purchasing power in order to positively push the market towards the provision of environment-friendly products and services, without causing disturbances and unfair competition.

# 7.2.6 "Green" banking products/services

The Bank has developed "green" banking products, which have a positive impact on the environment. Products such as the WWF Eurobank Visa and the "Green" Home Loans for the installation of household photovoltaic systems and the improvement of the Greek homes' Energy Efficiency are supported by specialized financing programmes.

Moreover, Eurobank Equity Partners, the Group's subsidiary, has developed and has been promoting a major investment product which, among others, supports dynamic companies of the Green Growth sector.

# **WWF** visa

WWF Eurobank Visa is the first "green" product ever issued by a Greek bank, and it is the outcome of the partnership between Eurobank and WWF Hellas, which began in 2000. Up to this date, WWF Hellas has received more than €1.97 million through WWF Eurobank Visa, in order to finance its environmental protection activities.

In 2014, the total number of active WWF Visa cards stood at 27.129, while Eurobank paid WWF Hellas the amount of €45,000, which once again came from:

- the one-off payments for each issuance and renewal of WWF Eurobank Visa cards
- the payment of a percentage on the value of purchases made by cardholders, without any charge to the latter

The amounts paid each year to WWF Hellas enable this organization both to preserve its independence and continue its work unhindered. The amount paid in 2014 was put to the following uses:

#### Scientific support (Jan-Dec 2014)

was used for financing important actions that provide scientific support to WWF's fieldwork, in regard to environmental policy issues, as well as communication (maps that highlight the problem of forest fires, maps recording the existence of lignite stations in Greece, ecological value of the coastal zone).

# Oikoskopio (Jan-Dec 2014)

was used for the maintenance and technical support of both the Greek and English versions of this web application, for the enrichment of Oikoskopion with new data, and for the addition of new games to the Oikoskopion kids site.





#### Dadia Forest National Park Programme (Jan.-Dec 2014):

was used for the study that the Dadia Forest team prepared in order to offer its own assessment and opinion on 5 wind farm environmental impact studies in Thrace, in conjunction with the organisation's proposal for the proper zoning of wind farms in the region.

#### Legal support voluntary team (Jan.-Dec 2014):

was used for supporting the policy researcher who, together with a team of 15 volunteers from diverse scientific backgrounds (lawyers, engineers, environmentalists), provides citizens with environmental information and advice in regard to environmental deterioration cases, such as industrial pollution, illegal logging etc.

# Management of the Sekania Beach, Zakynthos (Jan-Dec 2014):

used for financing, once again, part of the actions and campaigns in which the organisation is involved both as a member and as a co-organizer (in collaboration with other NGOs and the National Marine Park of Zakynthos) at the most important nesting beach of the loggerhead sea turtle in the Mediterranean.

# "Green" Home Loans

Eurobank has significantly contributed to the development of renewable energy sources, as well as energy-saving actions, as far as Greek households are concerned, offering a range of innovative products, under the Green Home Loan brand.

By means of the Special Programme for the installation of photovoltaics on residential rooftops, Eurobank helped more than 4,000 customers install PV systems. However, the dramatic drop in the purchase price of the power generated by these systems, has substantially reduced the economic gains from these investments, dragging along demand for the corresponding loans.

The Bank continues to support energy-saving efforts, by providing specialized financing programmes. In this context, supporting a rather important government initiative, the Bank participated, for a fourth consecutive year, in the state-subsidized "Saving at Home" programme of the Ministry of Productive Reconstruction, Environment and Energy (formerly the MEECC), offering, through its Sales Networks and the Branches of the Eurobank and New TT Branch Networks, the appropriate information and support to all those interested in improving the energy efficiency of their homes.

Already more than 10,800 customers have joined the programme through the Bank, and have proceeded to home interventions, thus achieving average energy efficiency gains of 40%, according to Ministry of Productive Reconstruction, Environment and Energy (formerly the MEECC) press releases, as well as major financial gains for the family budget.

Our invaluable experience and expertise in the field of Green loans will always provide a springboard for further initiatives, with the ultimate goal of helping upgrade the quality of both households and the environment at large.





# Financing of infrastructure projects for electricity generation from RES and/or other environment-friendly energy sources

In the past few years, the Bank has shown an unwavering commitment in supporting investments in the field of renewable energy sources (RES), which is part of the greater goal of financing the economy and supporting the country's growth.

The Bank has created special lending products for financing RES investments undertaken by small and medium-sized enterprises, such as PV's in business premises or rooftops, and PV parks and wind farms with installed capacities of up to 5 and 15MW respectively, also supporting large RES investments through more complex banking products, which cover the needs of large enterprises, emphasizing on structured Project Finance deals. It is worth noting that total new installed RES capacity, financed by the Bank in 2014 stood at 36MW.

The Bank is also engaged in financing other environment friendly investments, by financing projects for the generation of electricity from natural gas, which aim at replacing older polluting stations.

The Bank's target for 2015 is to expand its RES project lending portfolio and continue supporting Greek and foreign investors involved in this field.

#### e-Statement Service

The increase in the usage of the e-Statements service during 2014 was, once again, rather impressive, as 85% more e-Banking users chose to receive only electronic account statements. In total, 139.000 customers have discontinued the receipt of more than 416,000 physical statements over the conventional mail. The penetration rate of this service among active e-Banking users has reached 60%. The most important actions that led to the discontinuation of the physical statements were the targeted e-Banking "splash screen" that appeared in front of all e-Banking users who had never discontinued at least one physical statement, as well as the automatic discontinuation of all statements concerning new colleagues originating from New TT Branch Network.

Moreover, the savings for the Bank from the discontinuation of statement deliveries through conventional mail are also substantial and amount to more than €2 million since the service became available.

# Participation in environmentally aware enterprises, through Special Purpose Vehicles

The Bank is selectively participating, primarily with minority stakes, in companies with specific characteristics and strong growth prospects, emphasizing on extroversion and environmental awareness, and using, whenever necessary, co-investor funds. Apart, though, from financing capital, it also offers a wide range of advisory services and knowhow in regard to the development and growth of promising enterprises in Greece and abroad. In this context, the Bank has made the following investments:

# **MESOGEOS SA.:**

In 2010, Eurobank, together with a co-investor from the private sector, founded SINDA, with the aim of acquiring a stake in the share capital of MESOGEOS SA.

The MESOGEOS group of companies is one of the largest groups in the field of environmental protection in Greece. It is operating in the water and solid waste treatment markets, as well as in the sector of energy





generation from RES. It is a leader in the Greek market and has established a presence in Great Britain, Cyprus, and Romania, while its products are available in many countries.

The group's operations cover the following sectors:

- Solid & liquid waste
- Water resources
- Polluted soil restoration
- Urban environment upgrade
- Renewable Energy Sources

Despite the adverse overall financial environment, the Group maintains a satisfactory backlog and continues to secure major projects, continuously participating in tenders in Greece and abroad. Moreover, the group secured the refinancing of its loans with improved terms, which is expected to boost liquidity, and is also considering wider strategic growth and restructuring issues.

#### **NGP Plastic S.A.:**

In 2011, Eurobank, together with a co-investor from the private sector, founded FEMION, with the aim of acquiring a stake in the share capital NGP Plastic.

The NGP Plastic group, with vertically integrated, state-of-the-art facilities in Corinth and sales centres in lerapetra and Edessa, produces multi-layer and laminated film for the food industry, as well as specialized fruit and vegetable packages (cups, lids), mainly from recycled PET, PP and PLA. In this unfavourable overall financial environment the company is faced with liquidity, financing, and administrative challenges.

In Europe, specialized packaging for food products maintains its positive growth prospects for the forthcoming years, as both producers and consumers prefer the easier transportation and longer food duration, albeit without the use of chemical preservatives, that the sector can offer, and, moreover, are increasingly environmentally aware.

# 7.3 Corporate Social Responsibility and the Environment

Apart from its business activity, the Eurobank group has been developing social responsibility initiatives, in response to the needs of the societies in which it is operating. It maintains long-standing relations with acclaimed agencies and organizations, in order to realize initiatives in the critical fields of Education, the Society, Culture, Young Entrepreneurship, and Sports. In the field of the Environment, Eurobank has, for the past few years, been steadily supporting the work of the Scouts of Greece, participating in green area cleanup, landscaping and preservation initiatives all over Greece.
