

ANNOUNCEMENT

**Announcement pursuant to article 14 of L. 3556/2007
and article 7a (par. 6 case c) of L. 3864/2010**

Eurobank Ergasias SA (hereafter «Eurobank») announces, according to article 14 of L. 3556/2007 and article 7a (par. 6 case c) of L. 3864/2010, the following:

- Pursuant to the provisions of article 14 of L. 3556/2007 and based on the relevant notification that Eurobank received from the company “Pacific Investment Management Company LLC” (hereafter “PIMCO”), the percentage of Eurobank’s voting rights held indirectly by PIMCO, exceeded on 23.05.2019 the threshold of 5% of the total number of Eurobank’s voting rights, including those held by the Hellenic Financial Stability Fund (hereafter “HFSF”), and PIMCO’s percentage of voting rights amounted to 5.029%, corresponding to 186,540,345 voting rights of Eurobank’s ordinary shares.
- Pursuant to the provisions of article 7a (par. 6 case c) of L. 3864/2010 and based on the relevant notification that Eurobank received from PIMCO, the percentage of Eurobank’s voting rights held indirectly by PIMCO, exceeded on 23.05.2019, the threshold of 5% of the total number of Eurobank’s voting rights, excluding those held by the HFSF, and PIMCO’s percentage of voting rights amounted to 5.1%, corresponding to 186,540,345 voting rights of Eurobank’s ordinary shares.

PIMCO, in its role as an investment advisor or manager to the following investment funds, possesses the aforementioned voting rights and/or the investment power over Eurobank’s ordinary shares:
