



## **ANNOUNCEMENT**

## Announcement pursuant to article 7a (par. 6 case c) of L. 3864/2010

Eurobank Ergasias SA ("Eurobank") announces, pursuant to the provisions of article 7a (par. 6 case c) of L. 3864/2010, as in force, and based on the relevant notification received from the company "The Capital Group Companies, Inc." (hereafter "CGC"), that the percentage of Eurobank's voting rights held indirectly by CGC fell below on 29.01.2020 the threshold of 5% of the total number of Eurobank's voting rights, excluding those held by the Hellenic Financial Stability Fund, and CGC's percentage of voting rights in Eurobank's share capital amounted to 4.9831%, corresponding to 182,237,333 voting rights of Eurobank's ordinary shares.

The full chain of the companies through which the aforementioned voting rights are effectively held is outlined below:

CGC is the parent company of Capital Research and Management Company ("CRMC") and Capital Bank & Trust Company ("CB&T").
