

ANNOUNCEMENT

Notification of significant change in voting rights

Eurobank Ergasias Services and Holdings S.A. ("Company") announces, based on relevant notification received from the company Fairfax Financial Holdings Limited ("Fairfax"), that the percentage of the Company's voting rights held directly and indirectly by Fairfax, on 14.7.2021 amounted to 33.00% of the total number of the Company's voting rights, including the voting rights held by the Hellenic Financial Stability Fund ("HFSF"), a percentage corresponding to 1,224,002,259 voting rights of the Company's ordinary shares. Excluding the voting rights held by the HFSF, this percentage amounted to 33.47% of the Company's ordinary shares.

Moreover, the Company informs the investment community about Fairfax's notification to the Company dated 16.7.2021, with which it notified, in accordance with the provisions of article 7a (par. 6 case c) of law 3864/2010, as in force, that the percentage of the voting rights of the Company's ordinary shares held directly and indirectly by Fairfax exceeded on 14.7.2021 the percentage of 33.3% of the total number of the Company's voting rights, excluding the voting rights held by the HFSF, as it rose, as mentioned above, at 33.47%, whereas the chain of Fairfax's controlled legal entities that hold directly the aforementioned voting rights is outlined below:
